I (the undersigned) understand and agree that there are inherent risks associated with dog training and the dog sport of lure coursing and I assume full responsibility for all risks associated with my participation and hereby waiver, release, discharge, hold harmless, and agree not to hold Run Dog Run Lure Chasing llc, or its officers, employees, agents, volunteers, owner of property for event, or any other person or entity (hereinafter the "Released Parties") responsible to me or to my dog(s) for any injuries, illness, losses, wrongful death, damages, liabilities, damage to or loss to personal property, or expenses of any nature caused or alleged to be caused by the Released Parties' negligence or wrongful acts, conducts or omissions, breaches of any expressed or implied warranties when participating in a Run Dog Run Lure Chasing event.

I further agree to indemnify and hold harmless the Released Parties from any loss or damage to property to either the Released Parties, or any other person or entity, which may result from my property, negligence or intentional act or omission while participating in a Run Dog Run Lure Chasing llc event.
3. The Waiver and Release from Liability Form shall be construed in accordance with the laws of the State of Colorado. If any paragraph, sentence, clause, or phrase contained in this Waiver and Release from Liability form becomes, or is held by any court of competent jurisdiction to be illegal, null, or void or against public policy, the remaining content contained in this Waiver from Liability Form shall be construed broadly to provide a release and waiver to the maximum extent possible under the applicable law.

It is further understood that the Released Parties, or its affiliates, including but not limited to, its officers, directors, guests, agents, property owners and their successors, agents and assigns, reserves the right to refuse any entry and to eject any person from any activity sponsored by the Released Parties or its affiliates, or any property used by the Released Parties for an activity sponsored or operated by the Released Parties, for disorderly conduct, intoxication, or lack of control over a dog, or over any other object or being, caused by said person to be present at the activity, without refund of fees.
